2nd Annual Grants Open House

n August 24th, over 35 organizations attended our 2nd annual Grants Open House. After a warm welcome from our JLI President, Stacy Payne Miller, attendees had the opportunity to hear about the history of JLI's involvement with grants and the community from current EVP Lauren Weintraut. Attendees were able to learn about the grants process and ask questions directly to the grants chair.

What are Community Assistance Grants?

The Community Assistance Grants award a total of \$100,000 to 12 different nonprofit organizations that prepare students for academic success in Marion and surrounding counties. This year the application process will include a Letter of Intent prior to being invited to apply. Applicants will have the option of applying for funding for \$5,000 or up to \$25,000.

How can I participate?

Save the date for the December General Membership Meeting! The top 5 applicants will be pitching their projects at the meeting and members will vote who receives a \$25,000 grant. The four other organizations will all receive a \$10,000 grant. ■

Food Pantry Update

ne bag and smile at a time, the 15 members of the Food Pantry committee support Indianapolis children and families in need. Since it opened for the school year on July 29, the Stephen Foster Elementary "Bulldog" pantry has served around 80 families each month, many with six or more members, mostly children under the age of 18. Monthly, the League orders nearly one ton of food from Gleaner's Food Bank, and most of it is given away by the time of the next order. Since the pantry opened three years ago, it has distributed over 24 tons of food to families in need.

"I really enjoy helping the families of Stephen Foster Elementary School. Being able to work in the food pantry is exactly why I joined Junior League—to make a difference in our community," said Allison Hoyt, a new Food Pantry committee member. Allison, like her fellow committee members, will work around 10 shifts throughout the 2017-2018 school year. The pantry is operated by at least 3 League committee members every Saturday that school is in session from 10 am to Noon.

While the family size determines the amount of items families can take from pantry shelves, most walk or drive home with at least 3 large shopping bags filled with staple items like rice, canned vegetables and peanut butter. The League has partnered with Gleaner's Food Bank since 2014 to provide a monthly shipment of fresh and non-perishable items to the pantry.

Training Recap: How to Create Content for any Blog

t our first training opportunity of the year, held in August, we heard from one of our own members, Susan Baroncini-Moe, about how to create content for any blog (especially the JLI blog). The participants learned the first step to writing a blog is identifying your audience. The second step in the process is known as "The Terrible Struggle." This is when the blogger deals with 'Imposter Syndrome,' the feeling that they do not have enough knowledge to write about the particular topic they've chosen. To get past Imposter Syndrome, the blogger must give themselves permission to write, which involves telling yourself that you knowledgeable enough to write this topic, and push yourself to start generating ideas.

So how do you generate ideas for a blog? You ask yourself:

- Who's it for and what's the goal?
- Am I trying to educate, persuade or convert my audience and what's the best way to achieve my goal?

There are several styles of content including: how to guides; case studies; Q & A; interviews; inspirational messages; and there are many ways to present the content. Video, graphics and audio are just a few options. Video is the most popular.

Another area Susan covered in the training was using keywords in your writing. To do this, you must identify keyword opportunities, narrow your topic and write and optimize. Use the keyword in the title and throughout the article but don't overdo it in the body of the blog.

Finally, we discussed creating a title for the blog. The goal of the title is connect to your reader. You also want to use your keyword and catchy words to grab their attention.

That left us with one to do: go create content! Susan left us with these words of wisdom as we set out to create our first blogs: outline, execute, edit and publish. And don't be afraid to brainstorm and generate several ideas before narrowing it down to a specific keyword and topic.

If you've been thinking about creating a blog, keep in mind if you write one for the JLI you'll receive one (1) flex credit for any blog that is accepted for publication on the JLI Facebook page. And we can't think of a better way to get training in writing blogs than writing one for the JLI!
