Around the Community -Around the Clock 2017

In 2017, our mission is simple: honor the legacy built by generations of JLI leaders by making an even bigger impact on Indianapolis. In April, we worked tirelessly to serve our community for 95 consecutive hours.

A big THANK YOU goes out to all members who organized, shopped, participated and volunteered in our 2nd annual Around the Community - Around the Clock service event! We had 104 volunteers provide over 600 volunteer hours in our community. Those 600 hours add up quickly -the Independent Sector sets the national value of volunteer time at \$24.14 an hour, which means our work alone was worth \$14,484.00! To help give you a sense of the impact made in 95 hours, we want to share with you the projects we hosted, participated in, and the "numbers" that came from our efforts during this years community service blitz.

JLI Honored During Indiana General Assembly

he Indiana General Assembly recently honored the Junior League of Indianapolis by marking its 95th Anniversary with Senate Concurrent Resolution No. 36. The Resolution, honoring the League's storied history and acts of good work throughout Indiana, was read and approved in the Indiana Senate and House of Representatives on March 20, 2017.

The Resolution read, in part, "Whereas, it is fitting that the Indiana General Assembly honors JLI on the occasion of its 95th anniversary, commends JLI for its enduring commitment to bettering the community, and thanks JLI for its immeasurable service to Indianapolis: Therefore, be it resolved by the Senate of the Indiana General Assembly, the House of Representatives concurring: Section 1. That the Indiana General Assembly honors the Junior League of Indianapolis ("ILI") on the occasion of its 95th anniversary and thanks JLI for its many years of service to the community." The Resolution included mention of a number of the League's past and current projects, including: the Occupational Therapy Department at Riley Children's Hospital, hospitality services for the 1987 Pan Am Games, the Docent Program at the Indianapolis Museum of Art, partnership with the Susan G. Komen Race for the Cure, and Around the Community Around the Clock. The Resolution also highlighted the League's mission to train women in the areas of leadership and community service. The entirety of Senate Concurrent Resolution No. 36 may be read on the website of the Indiana General Assembly.

The Resolution was authored and presented on the

Senate floor by Senator Jim Merritt, who has had a long relationship with the JLI through his mother, Mrs. Jane Brown Merritt, President 1972-1974, and his wife, Mrs. Kelley Merritt. Twelve active members of the League, including members of the Board, were able to join Sen. Merritt on the Senate floor for the reading. After the approval on the Senate floor, attending League members joined friend of the League, Representative Carey Hamilton, on the floor of the House of Representatives for the House reading of Senate Concurrent Resolution No. 36. Representative Hamilton offered enthusiastic praise for the League and spoke highly of President Michelle Study-Campbell. ■
